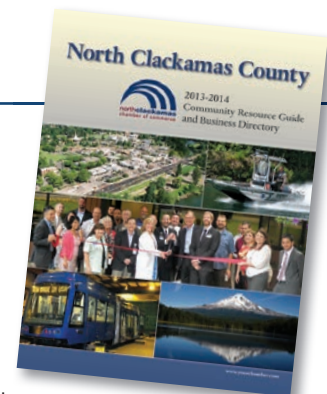

Whether you are a current resident or are seeking to relocate to this area, you will find North Clackamas County is a great place to live and do business. The region is poised to take advantage of the economic uplift. Our businesses report slowly increasing sales and the local housing market is making a strong rebound. North Clackamas County offers considerable housing diversity and opportunities for all socio-economic levels.

With a growing population pushing 400,000, Clackamas County offers the shopping and dining options you would expect in an urban area. Many of the most developed parts of the county are in the North Clackamas area. Because the county contains 1,879 square miles, there are also many rural areas and a variety of employment sectors throughout the county. We are one of the few areas in the region where heavy manufacturing remains solid. Continued job growth is expected to occur in health care and social services, professional and business services, and leisure & hospitality.

The largest and most prominent employers located in North Clackamas include Kaiser Sunnyside, PCC Structurals, Blount International, Fred Meyer, Warn Industries, Unified Grocers, Willamette View, Bob's Red Mill, The Oregon Military Department, Pacific Seafood, Safeway, NatureBake/Dave's Killer Bread and Pacific Scientific- OECO.

Major transportation projects are underway in North Clackamas County, including extension of the MAX Orange Line (Light Rail Transit from Portland into Milwaukie) and construction of the Sunrise Corridor from I-205 to Highway 212 at 122nd Avenue (this project also includes Lawnfield Road and Mather Road improvements in and around the Clackamas Industrial Area).

Visitors from around the world are attracted to the sheer beauty of this quaint community nestled in forested buttes and enriched with farmlands, nurseries and home based businesses. Exceptional views of Mt. Hood greet visitors as they travel eastbound through Damascus. THE COUNTY'S FASTEST GROWING CITY

Throughout family-friendly neighborhoods, parks and walking trails, or at its many community events, Happy Valley residents can visit with their neighbors and make new acquaintances. The City keeps its citizens connected in other ways, as well. Taking to the airwaves this year, the City launched its new radio station, AM1700, where it broadcasts city news and events, as well as important messages and information provided by partnering agencies 24 hours a day. Technology at City Hall provides visitors with free wireless internet access, and touch screen kiosks where they will find information about city services, local points of interest and print out forms and maps. Facebook followers can click on the City of Happy Valley's page for up to the minute news and happenings. A well designed, user-friendly website provides internet users with complete city services and information and offers citizens a sign-up to receive news flashes, emergency announcements or the monthly newsletter.

Happy Valley's economic and community development has gained considerable momentum in the last two years. Residential building construction activity has increased significantly and home prices continue to rebound throughout the Happy Valley area. An additional commercial building will soon begin construction in the existing Happy Valley Town Center shopping center. A 124-unit senior living facility is planned at 114th & Sunnyside and miscellaneous commercial development continues to expand in the city's growing business community, particularly along Sunnyside Road.

The community's local schools, police, fire and emergency services offer the best in education and protection for Happy Valley's citizens. Major medical providers offer easily accessible health care. Community centered development such as a new picnic shelter on Scouter's Mountain, a new "gateway" sign at the northeast corner of 122nd Avenue & Sunnyside Road, a newly opened skate park at Happy Valley Park

and major pedestrian and bicycle improvements along 145th Avenue and King Road demonstrate the great pride and innovation that the City takes in providing a well-balanced, well-designed community.

the Main Street Program, both indicators that downtown Milwaukie is primed for great things to come.

There are many other ways the City is preparing to capitalize on Light Rail's opening in 2015. The Fresh Look Downtown Project – aimed at bringing more vitality to the downtown core, the Neighborhood Main Streets Project – intended to activate commercial areas out in the neighborhoods, and the Tacoma Station Area Plan – preparing an entire neighborhood surrounding that light rail station for redevelopment, are all examples of the City proactively preparing to welcome new people and businesses to town.

In addition to an up-and-coming downtown, Milwaukie has a lot to offer residents and visitors alike: a developing Milwaukie Riverfront Park, a Sunday

CLACKAMAS COUNTY – A SERVICE ORGANIZATION.

Led by a five-member elected Board of County Commissioners, Clackamas County is made up of 1,879 square miles, much of it valuable wilderness area, and 383,590 residents. The North Clackamas area features a wide range of retail and commercial offerings blended with picturesque rural areas. The largest urban unincorporated area in North Clackamas includes the communities of Clackamas, Jennings Lodge, Oak Grove and Oak Lodge. If this area were incorporated, it would be the largest city in the county, with over 35,000 residents.

Whether immunizing school children, supporting new businesses and development, assisting senior citizens, looking after disabled or low-income residents, maintaining roads, or protecting the community, Clackamas County government is here to help.

In addition, Clackamas County hosts a number of taxpayer-supported special districts that provide services ranging from wastewater treatment, parks/recreation activities, and industrial

development, to libraries and streetlights.

The North Clackamas Aquatic Park is one highlight. The Aquatic Park features a kiddie pool, a dive well, a full-size swimming pool that draws high school swim teams throughout the year, water slides and a 29-foot climbing wall. Our residents also enjoy outdoor activities and take advantage of the many bike / pedestrian trails, nature walks, and parks in the region.

You can also visit Clackamas County's many assets, Mt. Hood and Timberline Lodge, Clackamas Town Center, the Portland Aquarium, Willamette Falls, the Oregon Military Museum, the McLoughlin House, Bob's Red Mill, the B17 Alliance Museum, the Canby Ferry, the Molalla Buckeroo, and the Clackamas County Fair and Rodeo.

Principal industries include agriculture, retail services, metals manufacturing, trucking / warehousing, nursery stock, wholesale trade and construction.
